## **DESCRIPTION**

**KEY #511-UV** is a clear, UV light resistant general purpose epoxy resin for use as primer, slurry binder, trowel mortar binder, broadcast systems, and coating applications. This resin has excellent clarity compared to standard epoxy formulations. It is essentially odorless and can therefore be used in occupied buildings. **KEY #511-UV** provides increased barrier thickness and gives added protection to concrete against chemical and abrasive attack.

**KEY #511-UV** is available in Clear only, may be tinted with UNVCP Universal Color Packs in Key Resin Standard Colors EXCEPT DO NOT use the following: 750 Blue, 185 Charcoal, decreased hardness will result.
